6:45 P.M. PUBLIC HEARING – CASE #2010-04 – KGB PROPERTIES/16 MILE BREWING CO

A Conditional Use one year review for the approval granted by Town Council on June 9, 2010. The property is located at 413 South Bedford Street, identified as Sussex County Tax District 135 Map 20.00 Parcels 50.00 & 50.04 zoned Neighborhood Business (UB2). Brett McCrae: Asked if Council could extend the hours for tours until 7:00pm on Monday thru Friday, and the yearly annual review. As it stands today it hard to obtain any type of financing to expand our business due to continual review by Council, the banks feel the permission can be taken away at any time, therefore our inability to repay the loan. In addition, to expanding the number of employees to fifteen.

Mayor Pettyjohn - Item #10 "Retail sales of alcohol are limited to on-site Micro-brewery product for off premise consumption".

Brett McCrae: That was how the old law used to read, as of July 2010 that was amended to read "on premise consumption."

Town Manager: There have not been any complaints filed against the brewery.

Mayor Pettyjohn: As far as the conditions - Has there been monthly reporting of the daily flows from your private well? Have you been doing that?

Brett McCrae: Uh-ha

Mayor Pettyjohn: Connection to the Town infrastructure for water & sewer?

Brett McCrea: Yes, it has been done for about a year.

Joe Newell, Park Avenue: If the application is not up for review in a year that leaves the application open-ended. He could do whatever he chooses to do.

Brett McCrea: Response not audible on tape.

Joe Newell, Park Avenue: I noticed that the property next to the road has been cleared. Gary McCrae I cleared the lot it has nothing to do with brewery at all.

3. ADOPTION OF AGENDA

ITEM #9A EXECUTIVE SESSION was added for a strategy session involving legal advice or opinion from an attorney-at-law with respect to pending or potential litigation.

Motion by Councilman Ricker, seconded by Councilman Barlow, to adopt the agenda as amended. **APPROVED (unanimous).**

4. APPROVAL OF JUNE 8, 2011 TOWN COUNCIL MINUTES

Motion by Councilman Barlow, seconded by Councilman Hartstein, to approve the minutes as presented. **APPROVED** (unanimous).

5. TICKET APPEAL – BRENDA E JOHNSON

Ms Brenda E Johnson received a ticket April 19, 2011 for parking overtime on the circle. Ms Johnson asked for an Appeal Board for dismissal of her ticket.

Ms Johnson claimed she was in Court at the time of ticket, my daughter was driving my car at the time, and she left to go to the store, and returned to park in the same spot. Ms Johnson claimed she had a witness seeing the vehicle leave and return to the same parking spot. Ms Johnson did not bring the witness with her.

Chief Topping – You have a copy of the law, Ms Reynolds documented the time and location of the violation, and without any other witnesses or any other evidence to be presented by Ms Johnson, it is pretty conclusive that she was parked there and Ms Reynolds did her job properly by citing her for parking overtime. It is also discussed earlier that same day that other employees in the Town Hall observed her parking there overtime.

Ms Johnson – The car was moved and I know for a fact it was moved.

Mayor Pettyjohn – All we're asking for some kind of co-operation, a receipt, a witness anything, to prove that the car was moved.

Motion by Councilman Ricker, seconded by Councilman Barlow, to deny the appeal of the parking ticket on the grounds there were no witnesses that were presented during testimony to collaborate the story.

APPROVED (unanimous).

6. CONDITIONAL USE APPLICATION - KGB PROPERTIES/16 MILE BREWING CO - CASE #2010-04

An application by Brett McCrea, on behalf of KGB Properties, for a conditional use to allow a beer brewery to be located at 409 & 413 South Bedford Street, identified as Sussex County Tax District 135 Map 20.00 Parcels 50.00 & 50.04 and are currently zoned Neighborhood Business (UB2).

Mayor Pettyjohn recommended the following changes to the Amended Exhibit A – Conditional Use Application – Case#2010-04.

Item#5 - Number of employees shall not exceed five to fifteen.

Item #10 – Public Tours, with onsite consumption, and retail sales may be conducted within the hours of 7 AM to 5 7 PM, Monday through Friday, and 9 AM to 6 PM on Saturday. Retail sales of alcohol are limited to on-site Micro-brewery product for off premise consumption.

Item #11 - Conditional Use application shall be scheduled for review in a public hearing by the Town Council one year after operation begins and one year after conditions are updated.

Motion by Councilman Ricker, seconded by Councilman Barlow, to amend Exhibit A to reflect the following changes. **APPROVED** (unanimous).

"Exhibit A is incorporated as part of the minutes."

6A. 1ST READING OF ORDINANCE

A. ORDINANCE #2011-15 YARD SALES

The Town has received complaints from residents and comments from our Code Enforcement Officer of several properties repeatedly holding yard sales on the weekend. No action at this time. 2nd reading and adoption if agreeable will be July 27th Town Council meeting.

Councilman Barlow voiced concerns over the allowed number of yard sales per year for churches and non-profit organizations. Councilman Barlow recommended that churches and non-profit organizations be exempt from this ordinance. Council agreed.

7. OFFICE OF DRINKING WATER – BINDING COMMITMENT OFFER DELAWARE DRINKING WATER STATE REVOLVING FUND LOAN

On behalf of the Delaware Drinking Water State Revolving Fund, has authorized a loan to the Town of Georgetown in the amount of \$2,199,410 at an interest rate of 0%, with 100% principal forgiveness, upon completion of the project. The Loan will be used for the costs associated with the installation of service mains & laterals. All legal costs, incurred, associated with loan closing shall be borne by the Town and may become part of the loan proceeds.

In the event the project is not completed, full amortization of the principal of any funds drawn over the course of construction on the project will be due and payable in semi-annual payments over a thirty (30) year term ("Loan Repayment").

Motion by Councilman Ricker, seconded by Councilman Barlow, to approve the Binding Commitment Letter for service mains & laterals. <u>APPROVED</u> (unanimous).

8. DEPARTMENTAL REPORTS

A. GENE DVORNICK – TOWN MANAGER

FY 2011 Audit

Audit fieldwork has been completed. The auditors will be returning occasionally in July for follow up items. It is anticipated that an audit report should be issued before September 1, 2011.

July Town Council Meeting

The Town Manager is scheduled to be away for the July 13th meeting and the Town Clerk will be out of the office for three weeks in July which includes the July 13th meeting.

Motion by Councilman Besche-Martin, seconded by Councilman Ricker, to cancel the July 13, 2011 Town Council Meeting. **APPROVED** (unanimous).

Pedestrian Crossing Signs

The Town has received some complaints from pedestrians trying to cross the Circle. In an attempt to make drivers more aware of the crosswalks and the associated pedestrians, a "State Law Stop for Pedestrians Within Crosswalk" safety sign was purchased and placed at the crossing where East Market Street enters The Circle. Due do positive feedback, it is suggested we purchase three (3) additional signs for the

other entrances to The Circle. The Town has permission from DelDOT provide the Town be responsible for purchase, installation and maintenance.

Motion by Councilman Ricker, seconded by Councilman Barlow, to authorize to purchase three (3) additional signs at an amount not to exceed \$1,000. **APPROVED** (unanimous).
